October 28, 2006 thru November 18, 2006 AFRICAN AMERICAN CHAMBER AND THE MTA IN WORKSHOPS FOR DISADVANTAGED/MINORITY/WOMEN-OWNED BUSINESSES

African American Chamber of Commerce of Westchester and Rockland Counties and the Metropolitan Transportation Authority (MTA)worked together to present workshops for disadvantaged, minority, or women-owned businesses. The program began October 28, 2006 and concluded November 18, 2006. The four-day, 32-hour program helps business owners compete successfully for contracts with the MTA and other government agencies. Historically, 76% of participants are awarded contracts.

The "Hudson Valley PREP (Preparing for Profit)" course was offered on Saturdays from October 28, 2006 thru November 18, 2006. Among the subjects covered in the \$110.00 course (funded by the MTA and the African American Chamber of Commerce) are marketing, cost estimating, accounting and navigating through a bureaucracy. The PREP course was held at the Chamber office in Mount Vernon, NY from 9:00am - 5:00pm, continental breakfast and lunch was served.
