JULY 2007**July 28 – August 18, 2007****AFRICAN AMERICAN CHAMBER OF COMMERCE AND THE MTA CONDUCT WORKSHOPS FOR DISADVANTAGED, MINORITY, OR WOMEN-OWNED BUSINESSES (PREP)**

African American Chamber of Commerce of Westchester and Rockland Counties and the Metropolitan Transportation Authority (MTA) are working together to present workshops for disadvantaged, minority, or women-owned businesses beginning in July 28, 2007 thru August 18, 2007. The four-day, 32-hour program has been successfully launched in other areas of the state to help business owners compete successfully for contracts with the MTA and other government agencies. Historically, 76% of participants are awarded contracts.

The "Hudson Valley PREP (Preparing for Profit)" course was offered on Saturdays from July 28, 2007 thru August 18, 2007. Among the subjects covered in the course (funded by the MTA and the African American Chamber of Commerce) are marketing, cost estimating, accounting and navigating through a bureaucracy. The PREP course was held at the Chamber office in Mount Vernon, NY from 9:00am - 5:00pm, continental breakfast and lunch will be served.

"The Metropolitan Transportation Authority joined efforts with the African American Chamber of Commerce to assist the Hudson Valley minority and small business community to effectively compete for MTA and other government agency contracts. We believe the PREP Program is an effective mechanism to facilitate this objective," said Kenneth A. Neal, director of the MTA's Civil Rights office.

"We are excited about bringing this opportunity to local businesses," said Robin Douglas of the African American Chamber of Commerce. "There are millions of dollars worth of contracts out there subject to competitive bidding, and these workshops help people find the keys to success in winning those contracts," she said. The MTA and other government agencies purchase a variety of services ranging from computers to landscaping, and printing to uniforms.

**REVOLVING LOAN FUND PROGRAM
FOR MINORITY OR WOMEN OWNED BUSINESSES**

Existing businesses will need two years of financials, along with a summary business plan detailing their current operations and need for the loan.

On Friday, June 20th there was Jazz with the Stars, hosted by Duke Jones, owner of Baseline, site of the event, a new Jazz Club in Mount Vernon. Hank "Perk" Perkins, owner of Perks restaurant in Harlem was co-host. Music was provided by Duke Jones and Friends.

The crowning event of the Celebration was the Annual Celebrity Salute to the Players of the Negro Baseball League Games, featuring teams made up of local celebrities and anyone else who wanted to come out and have a good time playing ball. Today, Juneteenth is a celebration of freedom which emphasizes education and achievement. Resolutions have been unanimously passed in the United States House of Representative and in the Senate encouraging the observance of Juneteenth with appropriate ceremonies, activities, and programs across the country, and asking that President Bush issue a Juneteenth Independence Day Proclamation.
